The city council of the city of DeQuincy met in regular session on the above date in the city hall council chambers located at 300 Holly Street, DeQuincy, Louisiana, with the following members present: Scott Wylie, Jim Smith, Bobby Dahlquist, and Margaret Brown. Absent: Cameron Smith

Council Member Bobby Dahlquist called the meeting to order at 5:30 p.m. Mayor Smith gave the invocation, and Scott Wylie led the pledge of allegiance.

A motion was made by Jim Smith and seconded by Scott Wylie to approve the November 10, 2025, regular meeting minutes. All approved, motion carried

FINANCIAL REPORT

One owner asked how the City could tell him and other owners to remove boards and repair their building when the City had two buildings in major need of condemning, those buildings are Old Town Hall and Grand Ave Gym. Council addressed the concerns.

There were two applications that had not come in, council did approve if the completed application and fee was turned in before December 31, 2025, the clerk could issue the permit. All approved, motion carried.

A motion was made by Scott Wylie and seconded by Jim Smith to authorize Mayor Smith to sign documents necessary to approve the re-appointment of Jerry McCaig to serve as a Commissioner of the Housing Authority for 5 years. All approved, motion carried.

A motion was made by Scott Wylie and seconded by Margaret Brown to approve a 6-month extension of a variance for Shelly Gaspard to live in a travel trailer on the property she owns at 732 Beech Street while her home is built on the property. All approved, motion carried.

A motion was made by Cameron Smith and seconded by Jim Smith to adopt a resolution to authorize Mayor Smith to act on behalf of the City of DeQuincy and take appropriate action to enter into a Cooperative Endeavor Agreement (CEA) between Calcasieu Parish Police Jury and the City of DeQuincy for cost share agreement with Animal Services. All approved, motion carried.

A motion was made by Scott Wylie and seconded by Jim Smith to adopt a Resolution to authorize Mayor Smith to act on behalf of the City of DeQuincy and take appropriate action to enter into Joint Services Agreement between Chennault Airport and DeQuincy Airport. All approved, motion carried.

A motion was made by Cameron Smith and seconded by Margaret Brown to adopt a resolution act on behalf of the City of DeQuincy and take appropriate action to enter into Cooperative Endeavor Agreement (CEA) with Infrastructure Consulting & Engineering, LLC ("ICE") for the provision of professional engineering services for airport development projects at the DeQuincy Industrial Airpark. All approved, motion carried.

A motion was made by Margaret Brown and seconded by Cameron Smith to adopt a resolution to authorize Mayor Smith to act on behalf of the City of DeQuincy and take appropriate action to enter into a Cooperative Endeavor Agreement (CEA) For Act 461 of 2025 RLS (State Aid to local government entities for improvements to City parks). All approved, motion carried.

A motion was made by Scott Wylie and seconded by Jim Smith to adopt a resolution to authorize Mayor Smith to act on behalf of the City of DeQuincy and take appropriate action to update agreement with DeQuincy Hospital. All approved, motion carried.

A motion was made by Scott Wylie and seconded by Jim Smith to introduce Ordinance # 1002, and set a public hearing for January 12, 2026, to declare property located TBD on Third Street, to become surplus property, and allow it to be sold through the bid process. All approved, motion carried.
